13. Description of Equipment or Protective System:

The FGard IR3 and FGard H2 Flame Detectors include an aluminium or stainless steel assembly consisting of a threaded enclosure body, a threaded back cover and a threaded window cover. An O-ring seal is provided at each end between the enclosure body and the back cover / window cover respectively in order to prevent the ingress of dust and water.

The electrical ratings are 32Vdc maximum and 700 mA (maximum). The ambient temperature range of the equipment is from -60°C to +85°C.

The equipment enclosure has as ingress protection rating of IP67.

14. Specific Conditions of Use:

The equipment shall be installed in places where there is a low risk of mechanical damage.

15. Essential Health and Safety Requirements:

The relevant EHSRs that have not been addressed by the standards listed in this certificate have been identified and assessed in the confidential report identified in item 8.
